## Notification Regarding Conducted of Examinations in Blended Mode

The Vice-chancellor is pleased to approve the recommendations of committee constituted for conduct of examinations in blended mode. There it is notified that the examinations commencing in Feb- March, 2022 will be conducted in blended mode i.e. the option of offline as well as online examinations will be provided to the candidates. Various guidelines and instructions regarding conduct of online examinations will be as follows:

- 1. The candidate can opt only one option, either offline or online.
- 2. The offline examinations will be conducted at examination centers as notified from time to time.
- 3. For option of online examinations the candidate can register through link of online examination available at www.crsu.ac.in or directly at http://crsuonlineexam.in.
- 4. The schedule of registration for online examinations will be as follows:

M.Ed. Semester-II	12/02/2022 from 11:00 AM	15/02/2022 up to 4:00 PM
UG- PG Semester-I, III and V	14/02/2022 from 11:00 AM	20/02/2022 up to 4:00 PM

- 5. The online examinations will be conducted with live monitoring.
- 6. The candidate opting online mode will have to arrange hardware of required specifications (Desktop / Laptop / Mobile with good camera) and high speed internet on its own.
- 7. The candidate is to undertake that he / she will be responsible for functioning of hardware and internet. No claim will be considered for malfunctioning of hardware / failure of internet or uploaded blurred (Non Readable) images and no reexaminations shall be conducted for such cases. Therefore Candidates are advised to choose offline examinations, if possible.
- 8. The Candidate has to sit alone in a room while appearing in online examinations. The candidates appearing at internet café or any other community places can be registered under Unfair Mean Case.
- 9. The candidate will not be allowed to leave his /her position in front of camera during tenure of examination. Any movement or doubtful activity will be considered as Unfair Means Case.
- 10. It will be compulsory to rotate the camera 360° as soon as the examination starts. During examination the candidate can be asked to rotate the camera by 360° i.e. all around just to ensure that no undesirable activity is practicing. If candidate will not do it, he / she may be registered under unfair means.
- 11. Malpractices noted down during online examinations shall be dealt strictly and no Benefit of Doubt may be given to the candidates for malpractices in online examinations.
- 12. The candidate has to write answers on A4 pages (format available on online examination portal) and is required to upload the pages on online examination portal.

- 13. The candidate can write on maximum 40 pages and upload these pages one by one in JPG Format or in a single PDF file format. Only one format is to be chosen and repeated uploading will erase the previous pages or files.
- 14. Only the pages uploaded through your login ID on University Online Examination Portal shall be considered and evaluated. No hard copy or email shall be considered.
- 15. The candidates should not share his / her user id and password with anyone.
- 16. The candidate shall not be allowed to appear in online exam after 30 minutes from the start of examinations.

Further also the Vice-Chancellor has approved the following recommendation of the committee regarding relaxation in pattern of examinations under considerations in anticipation approval of the Academic Council of the university.

"The candidate is allowed to attempt any five questions carrying equal marks. In Question Papers having unequal distribution of marks e.g. in case of Language Papers etc. the candidate can attempt as many parts of his / her choice subjected to the condition that total marks of such attempted parts of questions should not exceed maximum marks."
